

Enhancing the Participation of Community-based Organizations (CBOs) and Civil Society Organizations (CSOs) in Democratic Governance in Bangladesh







Prelude

The "Enhancing the Participation of Community-based Organizations (CBOs) and Civil Society Organizations (CSOs) in Democratic Governance in Bangladesh" is 3.5 years (2018-2021) initiative funded by the European Union (EU) and implemented by Oxfam and the Centre for Policy Dialogue, which seeks to enhance the participation of community-based organizations (CBOs) of vulnerable and marginalized communities (led by women) and civil society organizations (CSOs) in democratic governance in Bangladesh. The project aims to strengthen grassroots CBOs and CSOs to secure the social and economic rights of vulnerable individuals and communities in the design and implementation of government policies and budgets related to SDGs.

Project Goal



Enhance the participation of community-based organizations (CBOs) of vulnerable and marginalized communities (led by women) and civil society organizations (CSOs) in democratic governance in Bangladesh.

Expected Results to be Achieved by our Programme

Expected Result 1

CBOs and CSOs have enhanced organizational and influencing capacity to work with local authorities (LAs) to address government commitments on SDGs and the National Five-Year Plan (NFYP).

Expected Result 2

CBOs and CSOs support LAs to effectively deliver peoplecentered services as per existing laws and policies relating to SDGs.

Expected Result 3

Communities, CBOs, and CSOs hold LAs and interest groups accountable on existing laws and policies relating to SDGs.

Expected Result 4

Relevance and effectiveness of SDG framework is enhanced through contextualization at local, national and global levels.

The Context

Bangladesh has already translated the vision of a middle-income country, pronounced at the highest political level, into an actionable agenda. This offers tremendous opportunity to implement the 2030 agenda while reflecting the priorities of the SDGs in the national plan.

However, there have been consistent efforts to advance good governance in Bangladesh despite the challenging constraints posed on the processes. The key stakeholders have widely varying stances regarding their participation in democratic local governance in terms of role recognition, ownership, active participation, monitoring and follow-up of any development work.

Project Coverage

Project's Target Group

50,000 members of 325 women-led CBOs/CSOs and 300 CSO representatives of 13 districts.

A total of 450 local administration (LA) representatives responsible for administration of government services

650 local government representatives responsible for government oversight of service delivery

Final beneficiaries are approximately 175,000 women, men and childrenof CBO member household sand other stakeholders in 13 districts

How We Work

We work to organize communities and negotiate their needs with government representatives addressing different areas. Through that communities will be benefitting from improved knowledge on rights and entitlements with respect to SDGs, national and local policies, and Social Accountability (SAcc) tools, and improved social and institutional influence and networking.



Programmatic Approach

Multi-stakeholder approach

The project employs a multi-stakeholder approach across civil society and the public sector to seek long-term solutions to the challenges inhibiting solutions to structural issues of poverty, gender inequality, climate change, livelihoods and water management.

Cultivating community participation in governance

The project's interventions aim to institute citizen participation in planning and decision-making in the implementation of government policies and programs linked to the achievement of SDGs.

Innovative tools for public accountability and oversight

It employs and institutes accountability and oversight tools to be used by CBOs and CSOs to hold duty-bearers to account that have rarely been employed in governance in Bangladesh, particularly in rural areas.

Constructive government engagement for accountability

In recent years, the government has signed and endorsed several regional and global declarations and agreements without accompanying actions to ensure public accountability and citizen participation. The project will be a step forward in terms of enabling communities and civil society organizations to hold government accountable to these agreements.

Women's leadership and participation in decision-making

The project specifically targeted women-led organizations, guaranteeing that at least 60% of CBO/CSO members trained will be women. It incorporated women's experience and needs in the design of training, research and advocacy agendas, with a special emphasis on changing patriarchal attitudes towards gender roles throughout the implementation of the project.

Knowledge generation and evidence-based advocacy


The project will generate new knowledge and evidence on the ground level situation regarding SDGs/7th NFYP implementation process, current practices of service delivery and accountability, and participatory governance mechanisms, which will enable to initiate the dialogue, build the case of the action's agenda and influence targeted stakeholders in an effective manner.

Our Journey so far

A total of 325 grassroots community leaders are taking practical actions for localizing SDGs aligned to the slogan "Leaving No One Behind" to create positive social changes that will benefit to the broader communities of 13 districts. Since the inception of the project, it has been supporting marginalized people who are vulnerable to climate-induced disasters. The project participants substantially interact with different stakeholders i.e., civil society, self-help group, community leaders, and media. This initiative is facilitating 'social connectedness' by fostering knowledge, skills on SDGs-linked programmes, policies, and services. Both service recipients and service providers have been oriented with SDGs-linked programmes, policies and services. About 360 representatives of CBOs, 240 representatives of CSOs and 120 media personnel have been oriented with an aim to build their capacity to hold the government accountable on SDG targets. A total of 325 local administrators and local government representatives of 13 districts also took part in the 13 orientation sessions

A total of 325 CBOs, 300 CSO, and 65 media are united under 13 'District level networks for SDGs' where they share their development priorities, collectively identify solutions, and prepare their joint action plans. They are having six-monthly meetings accordingly. These districts level networks are linked with national Citizen's Platform for SDGs. The project is also fostering to build the capacity of CBOs on social accountablity (SAcc) tools and public finance management (PFM) tools that enable them to conduct evidence-based advocacy. About 300 CBO representatives (60% of them women) of 13 districts are now able to implement public finance management tools and social accountability tools.


Grassroots community leaders are preparing themselves to bring their issues at the National level Annual CBO/CSOconference to gain the attention of the policy makers. A Citizen's Charter will be adopted at the Annual CBO/CSO conference to highlight citizens' needs. There commendations and declarations from the conference will be captured by the Charter. It will be shared with the members of the National Parliament. and government officials of the relevant ministries and departments. At the sub-national level, dialogues have been organized to secure commitments from public authorities and policy makers on the local development agendas. A total of four subnational dialogues have been organized at Gaibandha, Sunamganj, Chittagong, Barguna on the efficacy of public services delivery related to social protection, agriculture, gender, and health respectively. These dialogues were participated by member of parliaments, local government representatives, local level government officials, representatives of various civil society and grassroots organizations, private sector, local media.
